



Security and Privacy Policy

Hafilat's Security and Privacy policy addresses our practices related to information collection & usage of your personal information.

Collection and Use of Online Information

Hafilat does not collect any personal information about you, when you visit **Hafilat** web site, unless otherwise specified or you choose to provide this information to us. However, we collect and store the following type of information automatically:

- The IP address, from which you accessed the Internet
- The date and time you access our website
- The pages you visited (recorded by the text and graphics files that compose the page)

We use this information solely for statistical and monitoring purposes. This helps us identify which services are most / less interesting to our visitors, as well identifying web site performance.

We may use third party tools or software for conducting statistical analysis; however please note that only certain pieces of aggregated, non-personal information, such as the number of users who accessed our website, or pages most visited etc are collected. Such information does not identify you individually. We will keep all collected information confidential except where disclosure is enforced or required by law, or as part of requirement to protect the rights or properties of **Hafilat**.

Protection of personal information:

When accessing some parts of this website or signing up to some services, you might be prompted to provide some personal information to disclose your identity such as the name, Emirates ID number, mobile number, date of birth, email id, gender, etc. and even your credit card number. All this information is essential to process your application. However, under no circumstance will your credit card number be stored. In case you opt not to disclose this data, you will be limiting our ability to serve you better, but nevertheless you will be allowed to access some parts of the website, as per these conditions.

Safe Transfer of Information

Please be assured that this site has security measures in place to protect the information you provide us. We use encryption methods to protect all information, which is deemed to be sensitive, or any other data that should remain secure to meet **Hafilat's**, federal or local legal requirements.
